### Before you get started

A permit is required if you, or a small group wish to busk on Council property which includes parks, footpaths, streets, or roads.

Busking activities can include;

- Playing a musical instrument/singing
- A performance juggling, miming, magic, dancing, art, puppetry, face painting.

or any other related activity that will occur on Council property.

### You will need

To include with this application;

- A copy of your current Public Liability/Risk insurance to a minimum of \$20 million dollars.
- A description of your Busking permformance, and the size of the area you wish to occupy

### Cost

- There is a cost per day. You will be charged for the total number of days you apply for the permit, regardless if you undertake the activity or not. Please refer to the Fees and Charges on our website.
- Busking permits are only valid for a 30 day period. If you wish to re-apply you will need to complete a new application.
- We will contact you to make payment if your application is approved.
